## 2022 TERMS & CONDITIONS

By submitting an enrolment and participating at U Can Dance, you are agreeing to the following Terms and Conditions.

#### 1. STUDENT CARE POLICY

Friendly, encouraging & caring behaviours only tolerated at U Can Dance.

#### 2. INFORMATION PACK

By submitting an enrolment and participating at U Can Dance, you are to have viewed the 2022 Information Pack.

#### 3. PAYMENT POLICY

It is agreed that all fees and costs incurred at U'Can Dance must be paid in full by the due dates outlined in the 2022 Information Pack & your Invoice. Upon enrolment you are agreeing to a minimum of one term and must pay for those classes, even if the student is absent.

#### 4. OUTSTANDING ACCOUNTS

Overdue accounts exceeding 14 days will have a late payment administration fee applied. Overdue accounts exceeding 28 days, will be forwarded to our Credit Management Company. If the account is referred for collection, additional collection charges will be levied against your debt.

#### 5. DUE DATES FOR FEES

A non refundable Registration fee of \$35 per student is required to be paid upon enrolment. Positions are confirmed when full payment of Term fees are received. All Term fees are due prior to the commencement of each Term, on the due dates outlined.

#### 6 . CONCERT PAYMENT POLICY

There are no refunds, transfers or credits for change of mind or decisions and events that lead to students not participating in concert. Concert fees that are not paid in full by the due date, will result in participation in concert ceased and costumes not sourced or provided. In the event that a concert is postponed, due to circumstances such as Covid 19 the event will be rescheduled and concert fees will be transferred to the new event date.

## **7. CANCELLED CLASSES**

In the event that U Can Dance needs to cancel a class for any unforeseen circumstances, if a make up class can not be offered by UCANDANCE, a credit for that class will be applied to your account.

## **8. REFUND POLICY**

There are no refunds, transfers or credits, including change of mind, family vacations, commitments, illness/ Injury.

## **9. NON ATTENDANCE**

There are no refunds, credits or make up classes for students who miss classes. If a student is unwell enough to dance, they are welcome to attend the class to observe.

## **10. COVID 19**

In the event that classes/events cannot run due to Government Directives or Public Health orders, if a make up class is not provided by UCANDANCE, a credit will be applied to your account. Refunds & credits will not be provided.

## **11. CONCERT PARTICIPATION POLICY**

Concerts are held at Eastbank Centre Shepparton. All students must participate in both shows. Students will be required to attend all rehearsals in order to participate.

## **13. CONCERT COSTS**

Please see the U Can Dance 2022 Information Pack for Student Concert Fees.

Concert tickets go on sale through Riverlinks from 1st November and are \$38 per ticket.

Parents are to budget for items required for concert, such as underwear, tights, hair and make up.

## **14. UNIFORM REQUIREMENTS**

Students are required to present to all classes dressed neatly in the required U Can Dance class attire.

Appropriate outer clothing should to be worn when entering and leaving the studio.

## **15. ATTENDANCE POLICY**

Where a student has been absent for lengthy periods without correspondence, their position will be passed onto a student on the wait list. We expect good attendance and team work in order for all students to progress and to avoid students performance participation to be limited.

## **16. TIMETABLES**

During Terms 3 & 4, timetables may change to reflect concert groupings.

## **17. CANCELLATION OF ENROLMENT POLICY**

If a student decides to discontinue classes at U Can Dance, administration must be notified via email.

Please notify us prior to the following new Term. If cancelling anytime after a term has commenced, fees

for that entire term must still be paid in full. Not attending, or not finishing the full term does not equate to a refund, transfer or credit.

## **18. TEAM APP**

All enrolled families must download and become a member on our U Can Dance Team App. News, documents and important information will be posted to the Team App and parents are responsible to be checking this regularly.

## **19. SUPERVISION OF STUDENTS POLICY**

Supervision out of class times is the responsibility of parents. Students must be signed in and out for all classes.

## **20. PHOTOGRAPHY & VIDEOGRAPHY**

You consent to photographs and video footage being taken of your child performing in classes, at concerts and events. This footage is to be used by U Can Dance, for social media, concert DVD's and promotional material only.

## **21. CHOREOGRAPHY**

All choreography and edited music, remains the property of U Can Dance and can not be replicated or reproduced. They are not permitted to be performed, or shared without prior written consent and approval from U Can Dance Principal.

## **22. PUBLIC HOLIDAYS**

There are no classes on public holidays, unless otherwise notified.

## **23. INCIDENTS/GRIEVANCES**

Any or all grievances, Incidents or complaints are to be directed to the principal of UCANDANCE via email. UCANDANCE is committed in ensuring your personal information is treated with the appropriate degree of privacy.

## **24. PHYSICAL CONTACT**

Physical contact, through technical placement and spotting is required in the study of dance. I/we realise, acknowledge and agree this is necessary to aid in the use of teaching dance.
